


Germicidal UV Light Installation Instructions











Air System Preparation







2a. Detach drain pan to access the area behind it.




2b. For systems with non-removable drain pan, remove louvers and baffles to access the area behind.





Installation Notes

Mini UV is typically used for mini split systems and other limited space applications. Because space is tight the best place for mounting the UV lights is usually inside the supply vent with the light shining onto the blower wheel (which is prone to the worst mold growth).

PROTECT EYES FROM UV LIGHT TURN OFF UNIT OR DISCONNECT BEFORE SERVICING





IMPORTANT!

Orient the UV lamps so that the light shines into the air system, not into the room

UV Lamp Mounting

 Determine the best location for the UV lamp clips and clean that area with the alcohol wipe. Slide the mounting brackets onto the ends of the UV lamps.






2. Peel off paper from the adhesive backing on the mounting brackets. Press the lamp with lamp clips firmly in place about 2" from blower wheel.


IMPORTANT!

Rotate the lamp so the warning sticker is visible and the UV light shines on blower wheel and mold prone areas, **NOT INTO THE ROOM**.



3. Pass the UV lamp cables through to the back of the AC system.

Power Supply Installation



Note: Some indoor systems may require additional wiring to provide line voltage to the Mini UV™ power supply.


1. Remove the control box cover and connect the wiring harness as shown.

TUVP-MINI-120 ballast wiring


- Black to hot terminal
- · White to neutral
- Green to ground

TUVP-MINI-208/230 ballast wiring

- · Black to line 1
- White to line 2
- Green to ground

- * Mini UV comes with one power supply, 120 or 230 VAC, confirm before installation.
- **3.** Insert the UV lamp cable connectors and wiring harness connector into the power supply.



Note: It can take up to 10 minutes for the UV lamp to warm up and fully illuminate.

4. Tuck the power supply into the line chase on the back of the ac unit or place it in or under the control box or other secure location.

- **5.** Return power to the system and confirm that Mini UV is working.
- **6.** Apply the UV warning sticker in an appropriate location.

Lamp Replacement

The germicidal UV lamp in Fresh-Aire Mini UV® needs to be replaced yearly. Germicidal effectiveness falls off over time so UV lamp replacement is necessary even if the lamps continue to emit visible light after one year.



Replace lamp only with part #TUVL-MINI

Note: Use of replacement UV lamps other than Fresh-Aire UV® voids warranty. **Caution:** UV lamps contain small amounts of mercury - dispose of lamps in accordance with local environmental regulations. For more information visit www.lamprecycle.org

What Will Triatomic Environmental, Inc. Do? Triatomic Environmental, Inc. will replace any defective or malfunctioning part at no charge. You must pay any labor charges and shipping charges of defective product to our warranty department.

What Does This Warranty Not Cover? THIS PRODUCT IS NOT INTENDED TO BE PURCHASED AND INSTALLED BY UNLICENSED HVAC OR ELECTRICAL CONTRACTORS. This warranty does not cover products or parts purchased from any source other than licensed HVAC or electrical contractors. This warranty does not cover parts installed by unlicensed HVAC or electrical contractors. This warranty does not cover parts damaged as a result of misuse, abuse, or any use other than its intended use, accident, acts of god, neglect, or from improper operation, maintenance, installation, modification or adjustments. Triatomic Environmental, Inc. shall have no responsibility for charges incurred by the customer for installation or removal of warranted items.

This warranty does not cover parts or equipment used with the Fresh-Aire UV system that are not manufactured by Triatomic Environmental, Inc.

**This warranty shall be void if UV lamps from manufacturer's other than Triatomic Environmental, Inc. are used with this equipment.

If something is wrong with your product, call your installing contractor to receive a Return Merchandise Authorization (RMA) and instructions for returning the product to a licensed distributor in your area or the manufacturer.

Once the product is returned, we will inspect your product and contact you within 10 business days of our receipt of the product to give the results of our inspection. If we determine that the product is covered under this warranty, we will ship to you at no additional cost a replacement part. Replacement parts may be refurbished. If we determine that the product is not covered under this warranty, or that this warranty is void, the product will be returned to you COD. There is no charge for inspection.
